

SUMMARY ANNUAL REPORT FOR
PIPE FITTERS' INDIVIDUAL ACCOUNT & 401(K) PLAN, LOCAL 597

This is a summary of the annual report for Pipe Fitters' Individual Account & 401(k) Plan, Local 597, EIN 36-1820310, for the year ended December 31, 2020. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by Trust.

The value of plan assets, after subtracting liabilities of the plan was \$1,706,831,627 as of December 31, 2020, compared to \$1,487,447,247 as of January 1, 2020. During the plan year, the plan experienced an increase in its net assets of \$219,384,380. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the plan's assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$318,446,251, including employer contributions of \$95,277,978, participant contributions of \$24,965,792, rollover contributions of \$3,454,052, gains from investments of \$191,901,711, interest from participant loans of \$1,736,803, and other income of \$1,109,915.

Plan expenses were \$99,061,871. These expenses included \$391,904 in administrative expenses, \$96,017,658 in benefits paid to participants and beneficiaries, \$61,149 in corrective distributions, and \$2,591,160 in deemed distributions. A total of 10,259 persons were participants in or beneficiaries of the plan at the end of the plan year.

The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
